RESOLUTION NO. 7780

Pursuant to the powers vested in it by the Constitution, the Omnibus Election Code, Republic Act No. 7160, Republic Act No. 9054, Republic Act No. 6734, Muslim Mindanao Autonomy Act No. 25, and other election laws, the Commission on Elections RESOLVED to adopt, as it hereby RESOLVES to adopt, the following Calendar of Activities and Periods on Prohibited Acts for the conduct of the December 30, 2006 plebiscites to ratify the creation of the following: (a) Municipalities of Pandag and Mangudadatu out of the mother Municipality of Buluan, Province of Maguindanao, pursuant to MMAA Nos. 203 and 204; (b) Municipality of Datu Anggal Midtimbang out of the Municipalities of Talayan and Talitay, Province of Maguindanao, pursuant to MMAA No. 206, and (c) Municipality of North Kabuntalan out of the mother municipality of Kabuntalan, Province of Shariff Kabunsuan, pursuant to MMAA No. 205; and (d) Barangay Gadunganpedpandaran out of Barangay Litayen, Parang, Maguindanao, pursuant to MMAA No. 82, to wit :

December 20, 2006 (WED) Submission to Comelec of complete list of all special policemen, special/confidential agents or persons performing similar functions in the employ of barangay chairman, municipal mayor or any appointing authority.

December 20, 2006 (WED) Last day for appointment of members of Plebiscite Committees

December 22, 2006 (FRI) to December 30, 2006 (SAT) Posting of the Certified List of Voters as of the August 8, 2005 ARMM elections,

December 29, 2006 (FRI) Inspection of Polling Places

1. Liquor Ban (starting 12 midnight) Selling, furnishing, offering, buying, serving, or taking intoxicating liquor, etc. (Sec. 261 (dd), (1), OEC).
2. Campaigning (Sec. 3, OEC).

December 30, 2006 (SAT) **PLEBISCITE DAY**

1. Cockfighting and other forms of gambling, holding fairs, boxing and/or any other similar sports. (Sec. 261 (dd) OEC)
2. Giving, accepting free transportation, food, drinks, and things of value (Sec. 89, OEC).
3. Selling, furnishing, offering, buying, serving, or taking intoxicating liquor, etc. (Sec. 261 (dd), (1), OEC).
4. Opening of booths or stalls for the sale of merchandise, refreshment, etc. within 30 meters radius from polling place (Sec. 261 (dd) (2) OEC).
5. 2. Campaigning (Sec. 3, OEC).

January 5, 2006 (Fri) **LAST DAY OF PLEBISCITE PERIOD**

Let this Resolution be published by the Education and Information Department (EID) in a newspaper of general circulation, and in a newspaper with local circulation in the Provinces of Maguindanao and Shariff Kabunsuan. The Deputy Executive Director for Operations shall furnish the Regional Election Director of ARMM, the Provincial Election Supervisors of Maguindanao and Shariff Kabunsuan and the Election Officers

of the Municipalities of Buluan, Talayan and Talitay, Province of Maguindano and of the Municipalities of Kabuntalan and Parang, Province of Shariff Kabunsuan, the Secretary of the Department of the Interior and Local Government, the Secretary of the Department of Education, the Provincial Governors of Maguindanao and Shariff Kabunsuan, the Municipal Treasurers and the DepEd Supervisors of the Municipalities of Buluan, Talayan and Talitay of Maguindanao, and of the Municipalities of Kabuntalan and Parang, Province of Shariff Kabunsuan, with a copy of this Resolution.

The Provincial Election Supervisors of Maguindanao and Shariff Kabunsuan, shall give this Resolution the widest publication in their provinces.

This Resolution shall take effect upon its publication.
