SUBJECT : NOTICE OF MEETING OF THE SPECIAL BOARD OF CANVASSERS

Pursuant to Section 18 of the Overseas Absentee Voting Law (R.A. 9189) and Section 60 of COMELEC Resolution No. 7740 dated 30 October 2006, notice is hereby given to all interested parties on the convening and meeting of the Special Board of Canvassers (SBOC) constituted in sixty two (62) Philippine embassies, two (2) Philippine consulates and one (1) Manila Economic and Cultural Office, abroad for the purpose of canvassing of votes for the national positions and party-list in the 2007 Senatorial and Party-Lists Elections.

The Board shall meet at 6:00 o'clock, in the evening Philippine time, of 14 May 2007 at the designated place in the respective Philippine embassies, consulates and MECO to receive the election returns and to immediately canvass those that have already been received (Section 61, COMELEC Resolution No. 7740).
