RESOLUTION NO. 8555

WHEREAS, a number of resolutions were promulgated on 12 November 2008 in connection with the December 18, 2008 Plebiscites in Taguig City and Tacloban City:


WHEREAS, there were inadvertent errors in certain provisions of these resolutions, as follows:

- a) In connection with the December 18, 2008 Plebiscite in Taguig City:
  - 1. In the title of Resolution Nos. 8540 and 8545, Barangay Upper Bicutan out of Central Bicutan should have been read as Barangay Central Bicutan out of Barangay Upper Bicutan;
  - 2. In Sec. 22 of Resolution No. 8541, the City Treasurer should have been the City Prosecutor;
  - 3. In Sec. 2 of Resolution No. 8544, the prohibited period should have been from December 17-18, 2008;
- b) In connection with the December 18, 2008 Plebiscite in Tacloban City:
  - 1. In Sec. 22 of Resolution No. 8516, the City Treasurer should have been the City Prosecutor;

NOW THEREFORE, the Commission RESOLVES, as it hereby RESOLVED, to amend Resolution Nos. 8540 and 8545 promulgated on 12 November 2008, such that the phrase "Barangay Upper Bicutan out of Barangay Central Bicutan," should read "Barangay Central Bicutan out of Barangay Upper Bicutan," Sec. 2 of Resolution No. 8544 promulgated on November 12, 2008, such that the prohibited period be read as December 17-18, 2008; and Sec. 22 of Resolution Nos. 8541 and 8516 promulgated on 12 November 2008 such that the "City Treasurer" should read as "City Prosecutor."

Let the Education and Information Department cause the immediate publication of this resolution.


