REQUEST FOR THE CONCURRENCE OF THE PRESIDENT OF THE REPUBLIC OF THE PHILIPPINES IN THE DEPUTATION OF THE NATIONAL POLICE COMMISSION AND THE PHILIPPINE NATIONAL POLICE, FOR THE PURPOSE OF ENSURING FREE, ORDERLY, HONEST, PEACEFUL AND CREDIBLE CONDUCT OF THE AUGUST 15, 2009 PLEBISCITE TO RATIFY THE CREATION OF A NEW BARANGAY TO BE SEGREGATED FROM BARANGAY MALANDAY TO BE NAMED AS BARANGAY MALANDAY DOS, AND RENAMING THE MOTHER BARANGAY AS BARANGAY MALANDAY UNO BOTH IN MARIKINA CITY PURSUANT TO CITY ORDINANCE NO. 207, SERIES OF 2008, APPROVED ON DECEMBER 17, 2008 BY THE SANGGUNIANG PANLUNGSOD OF MARIKINA CITY.

RESOLUTION NO. *8643*

WHEREAS, in the interest of free, orderly, honest, peaceful and credible conduct of the August 15, 2009 plebiscite to ratify the creation of a new Barangay to be segregated from Barangay Malanday to be named as Barangay Malanday Dos, and renaming the mother barangay as Barangay Malanday Uno, both in Marikina City, the Commission on Elections finds it necessary to deputize law enforcement agencies and instrumentalities of government;

WHEREAS, under Section 2 (4)(C), Article IX, of the Constitution of the Republic of the Philippines, such deputation requires the concurrence of the President of the Republic of the Philippines;

NOW, THEREFORE, The Commission on Elections RESOLVED to request, as it hereby RESOLVES to request, the concurrence of the President of the Republic of the Philippines in the Deputation of the Philippine National Police (PNP) and the National Police Commission (NAPOLCOM), in connection with the plebiscite to ratify the creation of a new Barangay to be segregated from Barangay Malanday to be named as Barangay Malanday Dos, and renaming the mother barangay as Barangay Malanday Uno, both in Marikina City, pursuant to City Ordinance No. 207, series of 2008, by the Sangguniang Panlungsod of Marikina City approved on December 17, 2008.


