WHEREAS, by virtue of Republic Act No. 9369, the Commission on Elections has been authorized to use an automated election system for the process of voting, counting of votes, consolidation, canvassing, and transmittal of results for the May 10, 2010 National and Local Elections;

WHEREAS, in pursuance of this mandate, the Commission procured a paper-based automated election system where precinct results are electronically transmitted from the precinct level to the canvassing centers;

WHEREAS, to ensure the effective and uninterrupted transmission of election results from the polling place to the canvassing centers for the May 10, 2010 National and Local Elections, there is a need to conduct VOTING CENTER SITE SURVEY;


WHEREAS, the Commission intends to deputize personnel of the AFP and the PNP to assist in the conduct of the survey by providing security and/or additional personnel in the conduct the VOTING CENTER SITE SURVEY;

WHEREAS, under Section 2, (4) C, Article IX, of the Constitution of the Republic of the Philippines, such deputation requires the concurrence of the President of the Republic of the Philippines;

NOW, THEREFORE, the Commission on Elections **RESOLVED** to request, as it hereby **RESOLVES** to request, the concurrence of the President of the Republic of the Philippines in the deputation of the Armed Forces of the Philippines and the Philippine National Police in the conduct of the abovementioned **VOTING CENTER SITE SURVEY**;

The Executive Director is hereby directed to furnish Her Excellency, the President of the Republic of the Philippines through the Honorable Executive Secretary, Malacañang Palace, a copy of this Resolution.
